5.2 <u>Planning</u> – Members considered the planning report from the Lead Member 19/01187/FUL Five Acres

Resolved: Council agreed to comment that, the building appeared on the plans to be stuck in the middle of a field and wondered why it could not be more 'discreetly' placed in the OPEN Green Belt land.

20/00003/FUL Shawbrook House

Resolved: Council agreed to object, this appeared it would never to be made into a garage from the first appearance of the building despite that being its only permission; this is on a dangerous bend and not designed to be for retail traffic such as visitors; delivery trucks etc, concern is if it is taken over in the future by a more retail business. Council object to the change of use because of these reasons.

Councillor drew attention that the current golf driving range off Euxton Lane was up for sale/lease and, it is in Green Belt. Clerk will obtain the sales details to see how the land is described it could be used/changed.

5.1 Co-option

Council was asked to consider co-opting to a Councillor vacancy from the 5 candidates.
